2020 Virtual AOM OSCM Division Annual Meeting

Greetings OSCM community!

If you have not done so already, now is a great time to start preparing for what is shaping up to be an exciting 2020 Virtual AOM Annual Meeting. While we will not be able to interact with friends and colleagues in-person this year, the virtual format of this year's conference offers several benefits including:

- Vastly more convenient to attend via the **one-stop virtual event platform Pathable**
- Access to 400+ synchronous (live) sessions and hundreds of additional asynchronous sessions across the Academy's numerous divisions
- Fewer scheduling conflicts. All synchronous sessions will be recorded for later viewing
- Authors can post supplemental information (papers, slides, recordings, etc.) for review and comment by attendees
- An extended collaboration and viewing period. Questions, answers, and comments can be added through August 31st. Supplemental session information is available through October 31st
- The ability to participate in the Virtual Career Fair
- The opportunity to meet one-on-one with publishers and other vendors at the Virtual Exhibit Hall

This year, the OSCM Division received 169 paper submissions, 3 symposia submissions, and 6 PDW submissions (including the Joint Doctoral Student & Junior Faculty Consortium). Thanks to the service of 218 members who signed up as reviewers, our review process resulted in the acceptance of 75 papers, 6 PDWs, and 3 co-sponsored symposia. These accepted contributions were offered placement in either the synchronous or asynchronous portion of the virtual program.

The table on the following page highlights the synchronous portion of the OSCM program which includes:

- The Joint Doctoral Student & Junior Faculty Consortium,
- 3 PDWs,
- 3 Best Paper sessions, and
- 2 Journal Award presentation meetings.

An effort was made to schedule these live sessions at times that were most convenient for the authors/presenters based on the time zones where they are located. If a session of interest is scheduled at a time that is inconvenient given your time zone, please remember that all sessions are recorded for later viewing.

In addition to synchronous sessions, conference registrants will have access to an extensive asynchronous program. Authors of papers accepted for the OSCM program, and not included in the sessions listed in the table on the following page, have the opportunity to post papers, slides, and video recordings to the AOM virtual conference platform. For the OSCM Division alone, this includes the potential for up to 63 additional papers. Conference participants will be able to view the shared materials, follow conversations, and engage in meaningful online dialogue.

The [complete AOM virtual program](#) should be available online before the end of July. Beyond what was mentioned above, the program will include:

- 400+ live sessions
- 1,400+ mock live and pre-recorded sessions
- Supplemental materials available for sessions, including presentation slides, videos, and other informational documents
- Discussion feeds and additional interactive engagement opportunities for all sessions


Financial health

Naturally, given the difficulties we all face due to the COVID-19 pandemic, including our institutions, it is understandable that this has also affected our own financial income in 2020. Membership


As can be seen in the left figure below, membership numbers have consistently grown until 2019, with a little dip in 2020 (in line with the total AOM drop off this year which is estimated to be around 8%). Because a part of our membership is linked to conference participation, and some participants had to withdraw from participation due to the virtual format, we expect this to be a temporary drop. Another point that stands out is the equal balance between US and International members. We aim to further develop our membership base on other continents. Our [OSCM membership committee](#) also reflects this ambition and is working on some initiatives to boost this. In terms of conference participation, engagement was strong going into the conference this year in terms of total submissions and number of reviewers who signed up. This bodes well for the level of excitement about our division.

Conference Participation Trends



Interview with New OSCM Division Committee Member

This Fall, **Prof. Dr. Kai Förstl** will start his five-year term as an executive committee member. We interviewed him to learn more about his background and ambitions with the OSCM division.



For those amongst us who do not yet know you, could you please briefly introduce yourself?

I am Kai Förstl, Professor of Supply Chain Management and Logistics right now at the German Graduate School of Management and Law, Germany, but this is coming to an end as per the Fall term 2020, I am transitioning back to the EBS Business School and that is in fact also where my academic career started. It is where I got my PhD and also spend most of my assistant professorship time. What is maybe more specific for me is that I started off with inductive case research, then I transitioned towards survey research and now I am mostly engaged in deductive studies, conducting experiments primarily; all in the context of supply chain management. Currently, we study teams within companies that make supply chain decisions, such as purchasing or operations planning, but also at the interface of the buyer and supplier. Through experiments we study how conflicts emerge, how they are resolved and which coordination mechanisms make these teams more effective.

If we go back a bit further, what made you take a job in academia? At the time I was writing my Master thesis on the topic of procurement, EBS had a vibrant, large supply chain management institute that was growing. The seemed happy with my work, so they approached me whether I wanted to become a research assistant. I also knew already a couple of doctoral students from there and they kind of dragged me in. I had also been at an internship at Audi's logistic department before, but when I had the choice I was leaning towards academia more.

You have already volunteered before as a OSCM Division Joint Junior Faculty & Doctoral Consortium coordinator 2018-2019. What made you return to the OSCM Division and nominate yourself for the executive committee? First of all, I enjoy our division and I like the Academy as a conference, a larger group and network. I just like to be involved in our community and have always enjoyed taking on these kinds of roles. When my tenure as an executive at IPSERA ended last year I decided to stand for election. Primarily because my fellow board members have established a very friendly atmosphere for the division that I would like to continue. I have learned a lot at the Academy and the OSCM division as I attended the conference since 2009. It is a great opportunity to give something back and have a positive impact.

That is great to hear. Being an executive committee member, which goals would you like to achieve for the OSCM Division? Well, I would like to draw the attention to the OSCM division within the wider community. Some have the impression that we borrow a lot from the other disciplines but I actually think we are doing quite well and we also develop novel ideas that leads to useful knowledge in today's business world. Hopefully we can draw more attention from people with main affiliations at other divisions and bring them in to the OSCM division. For instance involve them during socials, show them what we are doing and that we have cool topics and interesting methods. There could be a lot more mutual benefits still.

What would you like to keep and is there anything you would like to change for the better? We definitely need to keep the junior faculty and doctoral consortium: that is something where we, at an early stage of the academic career, can plant the seeds for the future generation of scholars. It is such a great network opportunity and friendly environment as a young, shy scholar to get in touch with all these big names in the editorial boards. That is a great kick start for academic careers. And I would definitely like to work on the cross-matching sessions and keep those. Previously other scholars in our division have also been very eager to bring in scholars from more general interest domains. And in terms of change? More socials ;) ! And although it is a challenging one, a company visit is something I would really like to bring back if people like this as well. As academics it is important to present your work and get published, but a little more practical stimulus could also foster novel research.

We all had to deal with severe changes in the past months. What is your take away on remote teaching? Obviously when we were struck by it there was so much going on that we simply converted to online lectures with only minor adjustments. But we quickly learnt that this style of lecturing does not work online. I learnt that it is worth spending your time on preparation and try to get the students to work and present what they have found. During the actual teaching hours I now take the role of an instructor or coach: this has changed even more now under the current conditions. I thought it is counterintuitive that you actually coach more over the distance, but this enhances students' attention span and engagement. It was also more pleasant for me because speaking to your camera or notebook for 45 minutes is not really rewarding. **Thanks for sharing your ideas, Kai, and good luck!**

Understanding Connect@AOM E-Mail Delivery Modes

Since the Fall of 2018, [Connect@AOM](#) is our communications platform at AOM. But if you didn't change your defaults since you started using it, you probably are not receiving the messages in the frequency you would expect. Let's dig deeper into the delivery modes, and you will then be able to adjust your settings to your liking.

For each community (Division, Interest Group, or other communities) you are part of, there are two sets of delivery options:

1. One deals with the reaction of Connect@AOM to each message that arrives.
2. The other deals with how it consolidates the messages for you.

The default setting is the daily digest. We recommend that you change it to Real Time, at least during the AOM 2020 Meeting, so that you can be notified in real-time during the conference as we plan for a series of news postings to highlight our OSCM Division program. You change those options navigating to "My Account" options, then "Community Notification Settings" (or clicking here: <https://connect.aom.org/network/members/profile/myaccount/my-settings?section=subscriptions>). This is what should appear for you:

For each community you belong to, you can choose one of the following settings:

- **Real Time:** every time a message is sent to that community and approved by the moderator, you get a copy in your email inbox. This is what we (Desirée van Dun and Iuri Gavronski) have in our settings for the OSCM community, and we assure you that it is not that noisy.
- **Daily Digest:** this is the default. All messages sent up to midnight (US Eastern Time) will be delivered to you the next day at 7 AM (US Eastern Time). In other words, all messages sent that very day will only show up in your inbox as a single message on 7 AM US East the next day. *Not very interactive, eh?*
- **Plain text:** delivers like the Real Time option, but the formatting and images will be removed. If you have a very limited data plan, that might be an option.
- **No email:** no message is sent to your email. You can always check the discussions (and reply to them) on the website or opt for a consolidated message (see below).

In **addition** to the above options, you can also choose to get a consolidated message. You can decide to have:

- A daily digest (works as above); **and**
- A weekly digest: all messages are consolidated and delivered Sunday at 7 AM. You can change the day of the delivery. All messages sent up to midnight US Eastern are sent to you.

Those options are cumulative. For example (don't ask why), you can have a real-time delivery, a daily digest, and a weekly digest, in case you missed something... People wanting to keep the noise to a minimum would set to no email and weekly digest. Finally, you can have a separate email to get all the discussions. Everything is set on the page we referred to above.

Again, the default is Daily Digest. For this reason, some people express their concerns to us whether for instance their job ad posting was delivered or not. In fact, it was probably delivered to only those who opted for real-time messages. Sometimes we simply missed it! If you sent a message and it was not delivered in, say, 24 hours, get back to us, and we will check what happened. Make sure you set the delivery option for OSCM to Real Time to make part of the conversation.
